b. Langley Pos-Abilities Society - "Try on a Disability" Event

Mayor van den Broek advised of four Council members and five senior staff's participation in Langley Pos-Abilities Society' recent "Try on a Disability "event, the purpose of which is to better understand daily life with a physical disability. She thanked Zosia and her team of volunteers at the Langley Pos-Abilities Society which is a non-profit volunteer supported agency that helps improve the quality of life for people with disabilities, including those living with mobility issues, hearing loss, blindness, plus many other conditions requiring assistive devices. She noted that the City issued a friendly challenge to the Township of Langley to participate in the event as well which they accepted.

c. Union of BC Municipalities Conference - Councillor Albrecht

It was a very busy week. It was from September 22 through to September 27th. It was very productive too. Total resolutions submitted were something like 285 and we were able to get to 178 on the convention floor by the delegates, 44 of those were referred to the UBCM Executive Board, so 63 were not debated at all.

We with six ministers, ministries: Education, Mental Health and Addictions, Finance, Transportation, Tourism, Arts and Culture, Public Safety and the Solicitor General.

I want to say thanks to Val, Rosemary and Nathan in representing our community quite well with the ministers and the staff. These meetings are critical in obtaining support for our community as well as building a rapport and relationship with the ministers and their staff to achieve future funding assistance and require services for the city. I think it's really, really

important. So we attended a number of policy sessions and workshops during the week such as ride hailing, libraries, supporting resilient communities, tackling the housing crisis, that's just to name a few.

The key note speaker was Peter Mansbridge and he did a really, really entertaining talk to us. That was great. The networking with other local government officials is really vital in helping to find out what is going on in other communities, what they've tried, what they've had successes with or failures, there's no sense in re-creating the wheel. So it's nice to be able to do that connection.

The highlight of my week was the opportunity to participate in Fire Training Ops 101. It was a hand's on experience on what firefighters do day to day. It was really rewarding and it was really appreciated and just a lot of fun; it was quite eye opening.

Want to give a special thanks to Francis and staff for preparing the information for us to be able to represent our community in an appropriate, professional and informed manner when we were meeting with the ministers and staff.

And as a side note it's an honour to be re-elected onto the UBCM Executive Board.

EXPLANATORY MEMO



2020 PERMISSIVE PROPERTY TAX EXEMPTION BYLAW NO. 3111

Under the Community Charter, Council has the ability to pass bylaws which exempt certain properties from property taxes.

The bylaw presented continues all exemptions included in the 2019 Permissive Property Tax Exemption Bylaw for a 1 year period.

Properties owned or occupied by the City

Community Police Office

The City of Langley Community Police Office is leased from a private company. To reduce the operating cost of the space, the City was able to exempt our portion of the building since we are the principal occupant. This exemption has been in place since 2007.

Non-profit occupiers of City land

The BC Assessment Authority considers any municipal owned land which is leased to a second party to be taxable. Under Section 224 of the Community Charter the City has the authority to provide a permissive exemption to these properties if they are occupied by a Non-profit Agency. In 2018, these exemptions reduced the City's portion of taxation revenue by \$108,572, which is 0.4% of the annual property taxes.

- 1. Langley Seniors Resource Society. The senior's centre is constructed on land leased from the City. The land and improvements became taxable in 1996 triggered by the registration of the lease. It was not the intent of the lease to change the taxable status of the facility; therefore, City Council approved a permissive exemption for the 1996 tax year, and has done so since.
- 2. Langley Stepping Stones Rehabilitative Society. In 1995, the Stepping Stones Society constructed a new facility on land leased to them by the City. When the lease was registered at the Land Titles Office the property reverted to a taxable status for the year 1996. City Council approved a permissive exemption for the 1996 tax year, and has done so since.
- 3. A portion of City Park owned by the City and leased to the Langley Community Music School Society (4809 207th Street). The property became taxable after the BC Assessment Authority undertook a review of non-municipal use of City owned land in 1997. City Council first approved a permissive exemption for the 1998 tax year.

- 4. Outdoor Langley Lawn Bowling Club. This is the Club's current outdoor facility adjacent to Douglas Park (20471 54th Ave). The property became taxable after the BC Assessment Authority undertook a review of nonmunicipal use of City owned land in 1997. City Council first approved a permissive exemption for the 1998 tax year.
- Langley Community Services Society which leases the City owned land at 5339 207th Street. The property became taxable after the BC Assessment Authority undertook a review of non-municipal use of City owned land in 1997. City Council first approved a permissive exemption for the 1998 tax year.
- 6. The Governing Council of the Salvation Army has constructed a shelter at 5787 Langley Bypass on land leased from the City of Langley. To reduce the operating costs of the new facility the City passed a permissive exemption for this property which commenced in 2009. In 2011 this property was assessed as a supportive living facility and the majority of the property assessment was reduced to \$2 similar to other designated facilities within the City. The entire property is being included in the bylaw, to ensure its exemption status is continued if the property class was to change.

Other existing Permissive Exemptions

There are 12 other properties within the City that currently have permissive exemptions. The properties are all non-profit and fall within our current Tax Exemption Policy. In 2018, these exemptions reduced the City's portion of taxation revenue by \$91,948, which is 0.34% of the annual property taxes.

- 1. Global School Society, a non-profit society which operates a Montessori school. Although this property receives a partial statutory exemption for the building and the land directly beneath it, the City has historically provided a permissive exemption for the remaining property, similar to churches. This exemption has been in place since 2001.
- 2. Southgate Christian Fellowship currently leases space at the Langley Mall (5501 204 St.). The property is not eligible for a statutory exemption like other churches because it is not the registered owner. In order to treat the church consistently with the other churches in the community, Council provided a permissive exemption for the church occupied space in 2009.
- 3. Langley Care Society. In 2005, the City was informed by BC Assessment they would be revoking a partial property tax exemption from the Langley Lodge located at 5451 204 St. The property had been receiving the partial exemption since 1974, the year following its opening. The City granted a permissive exemption which took effect in 2006 to continue the tax exemption on the property. During 2009 this society expanded its facility and requested an extension of the permissive exemption to cover the newly constructed facility. In 2010, the City continued the same exemption based on the original & new building value using the historical percentage of 18% for land and 93% for the buildings.
- 4. Langley Hospice Society purchased a property located at 20660 48 Ave in the fall of 2009. In the fall of 2010 City Council approved a permissive exemption which has been in place since.
- 5. Langley Association for Community Living approached the City in 2010 requesting permissive exemptions for 8 properties owned by the association used to support adults with developmental disabilities and children with special needs. In the fall of 2010 City Council approved a permissive exemption which has been in place since.

New applications for 2020

Langley Association for Community Living 312-5650 201A St

The City has received two new applications requesting permissive exemptions for 2020. A brief description of the application is below. The applicant is eligible for a permissive exemption under the Community Charter. In conjunction with the policy, City Council can consider application for permissive property tax exemptions from non-profit organizations which are viewed to provide a benefit to the residents of the City on a case by case basis.

- Langley Memorial Hospital Auxiliary (20560 Fraser Hwy) The • Langley Memorial Hospital Auxiliary purchased the property in December 2014 and operates Penny Pinchers at this location. A small portion of one of the buildings is being leased to a private company and that portion would be not included in a permissive exemption if it was to be granted. City Council denied a similar request from the Langley Memorial Hospital Auxiliary for the 2016, 2017, 2018, and 2019 taxation years.
- Langley Food Bank (5768 203 ST & 20308 Logan Ave) The Langley Food Bank has been at this location for over 30 years. City Council denied a similar request from the Langley Food Bank in prior years.

The bylaw has been drafted as the status quo, extending all existing permissive exemptions for an additional 1 year period. The new applications, from the Langley Memorial Hospital Auxiliary and the Langley Food Bank have not been included. This has been recommended by staff considering the current pressures on the financial resources of the City. Council would need to propose an amendment if they choose to include the exemption applications for the Langley Memorial Hospital Auxiliary and the Langley Food Bank with the bylaw.





PERMISSIVE TAX EXEMPTION

BYLAW NO. 3111

A Bylaw to exempt certain lands and improvements from municipal taxation for the year 2020

WHEREAS Council may, by bylaw, exempt properties from taxation for a fixed period of time pursuant to section 224 of the Community Charter, S.B.C 2003, c. 26;

NOW THEREFORE, the Council of the City of Langley, in open meeting assembled, enacts as follows:

- 1. Schedule "A" is attached to and forms parts of this bylaw
- The lands and improvements on the properties listed in Schedule "A" are hereby exempt from taxation under section 197(1)(a) [municipal property taxes] under the Community Charter, S.B.C. 2003, c. 26 for the calendar year of 2020 in accordance with the percentages set out in Schedule "A".
- 3. Bylaw may be cited as the "Permissive Tax Exemption Bylaw, 2019, No. 3111".

- 1. THAT City Council award the Tender T2019-029 Brydon Park Improvements (Phase 1) to Western Watershed Designs Inc. in the amount of \$633,425.00 (excluding GST).
- 2. THAT City Council authorize the Director of Engineering, Parks and Environment and the Corporate Officer to execute the contract document for the T2019-029 Brydon Park Improvements (Phase 1).

PURPOSE:

The purpose of the report is to seek authorization from Council to award the Brydon Park Improvements (Phase 1) tender T2019-029 to Western Watershed Designs Inc.

POLICY:

Purchasing Policy FN-12 requires Council approval for entering contracts for goods or services over \$375,000.

COMMENTS/ANALYSIS:

This project will selectively clear the western section of the park of underbrush and trees to open up sight lines through the park, create a new off-leash dog park and construct a new trail network.

Below is a site plan showing the proposed works.





The project was posted on BC Bid and was open to all bidders. A total of six (6) contractors submitted a bid. Western Watershed Designs Inc. is the lowest compliant bid at \$633,425.00 (excluding GST).

A list of Bidders and bid prices is provided below for reference. The tender analysis was completed by the city's consultant Binnie & Associates Ltd.

The reference checks have indicated acceptable performance.
