

## ALTERNATIVE APPROVAL PROCESS ELECTOR RESPONSE FORM

I am **OPPOSED** to the City of Langley proceeding with borrowing \$50 million as set out in the City of Langley Property Acquisition and Infrastructure Upgrades Loan Authorization Bylaw 2020, No. 3112, unless it is approved by Assent Voting.

I, the undersigned, hereby certify that:

- I am eighteen (18) years of age or older; and
- I am a Canadian citizen; and
- I have resided in British Columbia for at least the past six (6) months; and
- I have resided in, OR have been the registered owner of real property (and have been designated as the elector in regard to that property) in the City of Langley for at least the past thirty (30) days; and
- I am not disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in local elections; and
- I am entitled to sign this Alternative Approval Process Elector Response Form and have not previously signed an Alternative Approval Process Elector Response Form for the proposed Bylaw.

The Community Charter of the Province of British Columbia requires that in order for an Elector's Response to be valid:

1. The person signing the Elector Response Form is an eligible elector of the City of Langley as identified above ("I, the undersigned, hereby certify that:...").
2. The form must include full name, residential address and signature.
3. If signing as a Non-Resident Property Elector, address of real property in the City of Langley must be entered, as well as your residential address.
4. Only one Non-Resident Property Elector may sign an Elector Response Form per property. If the property is owned by more than one individual, written consent from a majority of owners to sign this form on their behalf must be provided. A Non-Resident Elector Consent Form can be obtained from the City's website at [langleycity.ca](http://langleycity.ca) or by contacting the Corporate Officer at 604-514-4591. **Property owned in whole or in part by a corporation does not qualify under the Non-Resident Property Elector provisions.**

All alternative approval process elector response forms containing original signatures must be either dropped off or mailed to the attention of the Corporate Officer, Administration Department, 2<sup>nd</sup> Floor, 20399 Douglas Crescent, Langley, BC V3A 4B3 by 4:30 p.m. on Tuesday, May 19, 2020. Faxed, imaged, or emailed signed forms cannot be counted.

NOTE: A person must not sign any alternative approval process elector response form more than once and may not withdraw his or her name from the alternative approval process elector response form after the deadline for submission of the petitions has passed.

The number of electors of the City of Langley is estimated to be 20,769. If 10% (2076) of the estimated number of electors of the City of Langley sign an alternative approval process elector response form opposing the noted borrowing unless it is approved by Assent Voting, Council will not be able to proceed with the borrowing without then receiving the assent of electors by Assent Voting.
