In accordance with Section 86 of the Community Charter, as the threshold of 10% of the estimated number of electors opposed to adoption of Property Acquisition Loan Authorization Bylaw 2021, No. 3145 unless it is approved by Assent Voting was not reached, the approval of the electors to adopt Property Acquisition Loan Authorization Bylaw 2021, No. 3145 was obtained.
