Hi Roy,

The role of Fisheries and Oceans Canada's (DFO's) Fish and Fish Habitat Protection Program (FFHPP) is to protect and conserve fish and fish habitat in support of Canada's coastal and inland fisheries resources, and to make regulatory decisions under the fisheries protection provisions of the *Fisheries Act*. The FFHPP is specifically responsible for reviewing projects for which a s. 34.4(2)(b) and s.35(2)(b) *Fisheries Act* Authorization is required.

DFO does not have a regulatory role related to the New Official Community Plan Bylaw No. 3200 because it does not directly propose works, undertakings or activities that may result in the death of fish and/or the harmful alteration, disruption or destruction of fish habitat.

DFO's Projects Near Water website (<http://www.dfo-mpo.gc.ca/pnw-ppe/index-eng.html>) includes information for proponents on how to comply with the *Fisheries Act*, request a DFO review of a project, and request a *Fisheries Act* authorization.
