RECOMMENDATION:

THAT Council authorize a letter of approval in principle be sent to the Minister of Public Safety and Solicitor General to maintain the detachment strength at 51.35 members and increase the 100% RCMP budget by \$260,434 for a RCMP total budget cap of \$11,586,126.

PURPOSE:

Each year, the City is required in accordance with our contract with the Province, to respond to the RCMP headquarters request for projections of the human and financial resource needs in 2022/2023 for Federal Government planning purposes.

POLICY:

None.

COMMENTS/ANALYSIS:

The RCMP Headquarters has initiated the planning process for the 2022/2023 annual budget. Each year they request that the City provide a letter of approval in principle to support staffing changes and a total budget estimate. This request facilitates the Federal Treasury Board's budgetary cycle. This letter is for planning purposes only and does not represent a final commitment on the part of the City. This request will be included in the City's 2022 Financial Plan for Council's deliberation early next year.

BUDGET IMPLICATIONS:

The City's RCMP contract budget reflected in the Financial Plan will increase in total approximately \$260,434 in 2022 (See Appendix 1). This includes an estimated 2.5% wage increase. This includes an 8.4% increase in integrated team costs.

Based on the information currently available, each member is budgeted at \$181,580. The funding decisions will be deferred until the Financial Plan is presented to Council in early 2022.

The actual strength reflected in the 2022 budget will be 51.35 + \$1,002,366 for the Integrated Teams excluding IHIT which will be billed separately by the Province.

We have been asked to reflect in the letter 100% of the RCMP costs even though the City is only responsible for 90% of the costs. The total budget cap in 2022 is therefore \$11,586,126 (see Appendix 2). The budget cap reported in 2021 was \$11,269,752 so the increase is \$316,374 (100%).

The City's Financial Plan budget for the RCMP contract is based on the calendar year and will total \$10,427,513 (90%) (see Appendix 2). In addition, the Province will bill the City separately for the IHIT costs of approximately \$415,000 and the Township of Langley equity sharing is approximately \$730,000.

Each year the City and Township share the total detachment costs calculated using an equity sharing formula based on the 5 year rolling average crime rates and population statistics. The calculation determined that the City should pay for 54.4 members however, our contract strength is 51.35. The cost for the extra 3.05 members is paid to the Township of Langley otherwise they will be overpaying for their share. We will not budget for any vacancies in 2022/2023, whereas in the prior year we budgeted for a 0.75 member vacancy.
