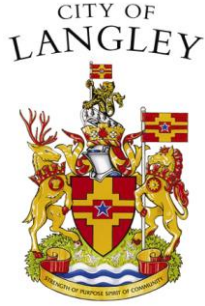
EXPLANATORY MEMO

WATERCOURSE PROTECTION BYLAW, 2021, No. 3152, AMENDMENT No. 1, 2021, No. 3181

PURPOSE:

The purpose of Bylaw No. 3181 is to:

1. Change the acceptable pH range from “6.5 to 8.0” in the bylaw to “6.5 to 9.0” to be within the range in the recent change in the Metro Vancouver Regional District’s drinking water pH level and consistent with provincial requirements; and
2. Add a requirement for the Qualified Environmental Professional (QEP) to sign a “Confirmation of Commitment” form prior to the commencement of the construction work.



**WATERCOURSE PROTECTION

A bylaw to protect watercourses in the City of Langley.

1. Title

(1) This bylaw shall be cited as the “Watercourse Protection, 2021, No. 3152, Amendment No. 1, 2021, No. 3181.”

2. Amendments

(1) “Watercourse Protection, 2021, No. 3152 is hereby amended by:

- (a) In Section 2. Prohibition of Discharges, subsection 1(a) in the phrase “6.5 to 8.0”, by replacing with “6.5 to 9.0”;
- (b) In Section 5. Inspection, Monitoring and Reporting Frequency, subsection 1 by adding the following:
“The retained QEP shall submit Form F-1 (attachment#1) to Engineering Services prior to the commencement of the construction work.”
- (c) In newly introduced Attachment#1 by adding Form F-1.
