EXPLANATORY NOTE

HIGHWAY AND TRAFFIC REGULATION BYLAW 2871,
AMENDMENT BYLAW No. 5, 2021
No. 3158

The purpose of Bylaw No. 3158 is to:

- remove the offence related to Commercial Vehicle Permits which are no longer issued by the City of Langley;
- remove Schedule "A" Voluntary Penalties and all references to "Schedule "A" Voluntary Penalties as all penalties referred to in Schedule "A" Voluntary Penalties will be moved to the new Bylaw Adjudication Bylaw;
- provide housekeeping amendments.



HIGHWAY AND TRAFFIC REGULATION BYLAW 2871,

A Bylaw to amend the Highway and Traffic Regulation Bylaw.

The Council of the City of Langley, in open meeting assembled, enacts as follows:

Title

1. This bylaw shall be cited as the “Highway and Traffic Regulation Bylaw, 2013, No. 2871, Amendment Bylaw No. 5, 2021, No. 3158”.

Amendments

2. Highway and Traffic Regulation Bylaw 2871 is hereby amended:

a) In Section 2. Definitions:

- i) By removing the following:
“(6) Commercial Vehicle” means a vehicle displaying a current commercial decal issued by the City of Langley except those vehicles exempted from registration and licensing under the Motor Vehicle Act.”.
- ii) By renumbering remaining definitions accordingly.

b) In Section 6. Parking and Stopping:

- i) Under subsection (1), by replacing the following:
“(f) on a sidewalk, crosswalk, boulevard or median;”
with
“(f) sidewalk;
(g) cross walk;
(h) boulevard;

(i) median;”.

ii) By re-alphabetizing remaining sections of subsection (1) accordingly.

iii) Under Subsection (3) Idling, by replacing the following:

“(a) No person shall cause or permit a vehicle to idle:

(i) for more than three minutes in a 60 minute period; or

(ii) while unattended.”.

with

“(a) No person shall cause or permit a vehicle to idle:

(i) for more than three minutes in a 60-minute period.

iv) Under Subsection (7)(a) Disabled Parking, by replacing the following:

“(i) a valid “Disabled Persons Parking Placard” issued pursuant to Division 38 of the Motor Vehicle Regulation, BC Regulation 26/58; or”.

with

“(i) a valid “Disabled Persons Parking Placard” issued pursuant to Division 38 of the Motor Vehicle Act Regulations, BC Regulation 26/58; or”.

c) By removing Schedule “A” Voluntary Penalties in its entirety and any reference to Schedule “A” in the bylaw.

d) By renaming “Schedule “B” Truck Route” to “Schedule “A” Truck Route”;

e) By renaming “Schedule “C” Bicycle Riding on Sidewalk Prohibited” to “Schedule “B” Bicycle Riding on Sidewalk Prohibited”;

f) Under Section 5 Traffic Regulations, subsection 16(a)(i), by replacing reference to Schedule “C” with Schedule “B”;

- g) Under Section 7 Extraordinary Traffic Control, subsection (2) Truck Route, by replacing reference to Schedule "B" with Schedule "A".
