



2022 DELEGATES AND REPRESENTATIVES APPOINTMENTS

PURPOSE:

The attached 2022 Delegates and Representatives Appointments list was prepared in compliance with recently approved Advisory Bodies Policy CO-79.

Below, as defined in Policy CO-79, are definitions for the following terms that are referenced in the list:

Chair: the individual responsible for presiding at a meeting and ensuring meeting procedures are adhered to and that the meeting is conducted in an effective manner

Co-Chair: in the absence of the Chair, the individual responsible for presiding at Council Committee and Task Group meetings and ensuring meeting procedures are adhered to and that the meeting is conducted in an effective manner

Council Representative: Council member formally appointed to be Council's representative on a specific committee, board, or working group

Alternate: the Council member formally appointed to be Council's Representative at meetings when the Council member appointed to be Council's Representative on a specific external board or working group is unable to attend

Changes from the 2021 list are provided below for information:

- “Co-Chair” has replaced “Vice-Chair” wherever it appears or has been added where previously there was no reference to a Co-Chair;
- “Alternate” has been added where there was previously no reference as to the Council member’s role on the External Board, Committee or Working Group:
 - Langley Human Dignity Coalition
 - Langley Local Immigration Partnership
- “Council Representative” has been added where there was previously no reference as to the Council member’s role on the External Board or Committee or Working Group:
 - Discover Langley City
 - Downtown Langley Business Association
 - Fraser Health Municipal Advisory Council
 - Gateway of Hope Community Council
- “Council Representative” replaces the term “Co-Chair” for advisory bodies that are categorized as an External Board, Committee or Working group:
 - Healthier Community Partnerships
 - Langley Local Immigration Partnership
- Langley Christmas Wish Breakfast has been added to the list
- Staff who support the following advisory bodies have been identified:
 - Langley Christmas Bureau
 - Langley Christmas Wish Breakfast
- Joint School Board #35 / Municipal Liaison Committee - Council members have been identified as Chair and Co-Chair, previously there was no reference to role; it is noted that the Chair shares chairing duties with another member of the Committee
- CP Community Advisory Panel - Council members have been identified as Chair and Co-Chair, previously they were identified as Co-Chair and Alternate Co-Chair; it is noted that the Chair shares chairing duties with another member of the Panel

For reference, the following advisory bodies have been removed from the 2022 list for the reasons indicated:

- Community Grant Review Committee – disbanded
- Douglas Day - event run by Township of Langley
- Emergency Planning Committee – is operational statutory committee, Council representation not required
- Finance Committee – is no longer active
- Fraser Valley Regional Library Board – appointments have been made previously per Library Act
- Homelessness Action Table – is no longer active
- Langley Secondary School Round Table – is no longer active
- Langley Senior Resources Centre Society - meetings conflict with Council meeting schedule; can receive updates through alternative means
- Langley Walk Committee – is part of staff’s work plan, Council representation not required
- Local Government Awareness Day - is part of staff’s work plan, Council representation not required
- Lower Mainland District RCMP Mayors Forum – Mayor is Ex officio member, no appointment required
- Metro Vancouver Board of Directors - appointments have been made previously to meet Metro Vancouver’s appointment deadline
