## EXPLANATORY MEMO

**PARKS AND PUBLIC FACILITIES REGULATION BYLAW, 2018, No. 3048,  
AMENDMENT NO. 2, 2023  
BYLAW No. 3243**

The purpose of Bylaw 3243 is to amend the Parks and Public Facilities Regulations Bylaw, 2018, No. 3048 to permit consumption of liquor in selected parks and public facilities.



**PARKS AND PUBLIC FACILITIES REGULATION BYLAW, 2018,

A Bylaw to amend the Parks and Public Facilities Regulation Bylaw, 2018, No. 3048.

The Council of the City of Langley, in open meeting assembled, enacts as follows:

**(1) Title**

- (1) This bylaw shall be cited as the “Parks and Public Facilities Regulation Bylaw, 2018, No. 3048, Amendment No. 2, 2023, Bylaw No. 3243”.

**(2) Amendments**

- (1) Parks and Public Facilities Regulation Bylaw, 2018, No. 3048 is hereby amended:

(a) By replacing Section 11(b)vii. which reads as follows:

**“Behaviour and Conduct**

11. (b) No Person shall:

- vii. consume or have in their possession any Liquor or Controlled Substance in a Park or Public Facility unless the Liquor or Controlled Substance is consumed or possessed pursuant to and in compliance with a licence issued under the Liquor Control and Licensing Act S.B.C 2015, c. 19 or the Controlled Drugs and Substances Act, S.C. 1996, c. 19;”

with the following:

**“Behaviour and Conduct**

12. (b) No Person shall:

- vii. consume or have in their possession any Liquor or Controlled Substance in a Park or Public Facility unless the Liquor or Controlled Substance is consumed or possessed

pursuant to and in compliance with a license issued under the Liquor Control and Licensing Act S.B.C 2015, c. 19 or the Controlled Drugs and Substances Act, S.C. 1996, c. 19, except under Part 3 – General Regulations, Consumption of Liquor at Selected Parks and Public Facilities;

(b) Under Part 3 – General Regulations, by adding the following:

**“Consumption of Liquor at Selected Parks and Public Facilities**

21. Consumption of liquor is permitted every Thursday to Saturday from 11:00 am to 8:00 pm, and every Sunday from 11:00 am to 6:00 pm from June 1st to October 31st each year at the following locations:

- McBurney Plaza;
- Designated area in Douglas Park; and
- Picnic shelters at City Park.”
