

I am **OPPOSED** to the City of Langley proceeding with borrowing \$15 million as set out in the City of Langley Property Acquisition, Infrastructure Upgrade and Improvement Loan Authorization Bylaw 2023, No. 3234, unless it is approved by Assent Voting.

I, the undersigned, hereby certify that:

- I am eighteen (18) years of age or older; and
- I am a Canadian citizen; and
- I have resided in British Columbia for at least six months immediately before the day the response form is signed; and
- I reside in, OR am the registered owner of real property (and have been designated as the elector in regard to that property) in the City of Langley; and
- I am not disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in local elections; and
- I am entitled to sign this Alternative Approval Process Elector Response Form and have not previously signed an Alternative Approval Process Elector Response Form for the proposed Bylaw.

Note: If you are signing as a Non-Resident Property Elector, you must have owned the real property for at least 30 days immediately before the day the response form is signed. The address of the real property in the City of Langley must be entered, as well as your residential address.

Only one Non-Resident Property Elector may sign an Elector Response Form per property. If the property is owned by more than one individual, written consent from a majority of owners to sign this form on their behalf must be provided. A Non-Resident Property Elector Consent Form can be obtained from the City's website at [langleycity.ca](http://langleycity.ca) or by contacting the Corporate Officer at 604-514-4591. **Property owned in whole or in part by a corporation does not qualify under the Non-Resident Property Elector provisions.**

**DEADLINE FOR SUBMISSION:**

**The completed form must be submitted on or before 4:30 p.m. on Tuesday, July 18, 2023. Any forms submitted after this deadline will not be counted.**

Completed alternative approval process elector response forms may only be submitted as follows:

The Council for the City of Langley may proceed with the adoption of City of Langley Property Acquisition, Infrastructure Upgrade and Improvement Loan Authorization Bylaw 2023, No. 3234 unless 2,207 eligible electors sign and submit a completed copy of this elector response form to the local government by the deadline.
