a. Crime Severity Index Conference

Verbal Report: Mayor Pachal

Mayor Pachal advised of the receipt of correspondence from the Mayor of the City of North Battleford, Saskatchewan inviting a representative from the City to attend their Crime Severity Index Conference to be held February 28 – 29, 2024 in Saskatchewan. The purpose of the conference

is to bring together the 20 highest ranked communities under the federal Crime Severity Index with populations of more that 10,000 residents, to discuss common struggles faced by this ranking system and to hold a media opportunity to collectively discuss these issues and challenge this negative narrative.

Following discussion, there was unanimous consent of Council to have this item brought forward to the next Regular Council meeting for consideration of providing approval for the Chair and Co-Chair of the Crime Prevention Committee to attend the conference.
