## 3. MAYOR'S REPORT

b. Metro Vancouver - Councillor Storteboom

The Metro Vancouver Board of Directors has not met since our most recent City Council Meeting. Likewise, our first meeting of the Climate Action Committee Meeting is scheduled for this Wednesday at 9 AM. Staff is reminded to report and reapply to the Sustainable Innovation Fund for this year's grant from Metro to support the ongoing Urban Farm Project that the City of Langley has in partnership with Kwantlen Polytechnic University.

Also, please note that Metro Vancouver is updating the region-wide Water Shortage Response Plan that regulates how residents, businesses and local government use drinking water in the summer months and during periods of water shortages.

As part of the public engagement process, Metro plans to host a series of Sustainability Dialogues. Council, staff and the public are encouraged to attend and join in these discussions about proposed changes to this important regional plan. c. Engineering Update - Rick Bomhof, Director of Engineering, Parks & Environment

The Director of Engineering, Parks and Environment reviewed the department's activities over the last month. Snow and ice control was the major focus for crews who worked diligently to keep City roads drivable. He reminded residents and business owners of their responsibilities to the remove snow and ice from sidewalks and boulevards surrounding their property.

Changes to sprinkling regulations and water usage in the region will be taking place in 2018 and as such Metro Vancouver is seeking input from the public through consultation on the Water Shortage Response Plan. Deadline for public comment is January 31, 2017.

A review of current construction projects was provided and it was noted that there have been some delays due to inclement weather.

d. Recreation Update - Kim Hilton, Director of Recreation, Culture & Community Services

The Director of Recreation, Culture and Community Services provided an update of programs taking place in January which included activities related to learning, play, sports and fitness. BEFORE THE QUESTION WAS CALLED the Director of Corporate Services provided an overview of the 2017 - 2021 Financial Plan. He reviewed the Capital Improvement Plan, Operating Budget (cost drivers) and the Tax Rate effect. He reviewed the funding sources for Capital Improvement projects, the allocation of casino funds, and the City's priorities in 2017 which included: Public Safety; Homelessness; Parks, Boulevards and Trails; Infrastructure Renewal and Recreation Opportunities. He advised that a total tax revenue increase of 3.61% is required to close the gap between revenues and expenditures, excluding services that are not under the control of city council like TransLink and School Taxes. He noted that the City's portion of the tax bill is about 63% of the overall the property tax notice.

Including taxes and utilities, the average strata property owner will see an overall increase of 3.2% and the average single family home will increase by 5.92%. The public have an opportunity to learn more about the budget at the Open House on February 1<sup>st</sup> at Langley City Hall, and can address Council directly at the February 6<sup>th</sup> regular council meeting.

Mayor Schaffer noted that Council will be lobbying the province to separate single family and multi-family residential property tax classes much like the distinction was made between light and heavy industrial.
